Bob from Apex and Diana have been discussing the issues with the water tower and possible funding to replace the tower. The tower is 30 years old. Diana will check to see if Bob is available to come to the February meeting to discuss options.

Richard inquired on the bill from Ulteig and it was forwarded to the City attorney and he will get a letter drafted up.

Richard was inquiring if we needed to read pumps on the weekend. It will stay the same at this time.
